#### Notes

1. To promulgate changes to aeronautical information via AIPNZ and NOTAM, your details must be current in the AIM register of authorised originators. See [www.originators.aeropath.co.nz](http://www.originators.aeropath.co.nz) for further information on originators and submission guidelines.
2. The indicated cut-off date is the final date for receiving submissions. Originators do not need to wait for the cut-off before submitting changes to AIM. It is desirable to submit planned changes well before the cut-off date as soon as they are available, particularly when the changes are numerous or complex in nature, including the development of AIP charts and SUP graphics.
3. In the case of changes that may require external consultation to be conducted by the CAA, it is recommended that these proposed changes are sent to CAA well in advance of the CAA cut-off date e.g. Airspace changes (Part 71), Airspace Hazards (Part 77), Air shows, complex changes, etc.
4. **Colour coding** Green = AIP/SUP cycle only. Blue = mid year AIP/SUP/ENRC/ARC cycle. Red = cut-off dates for AIP/SUP/ENRC/ARC/VNC. Maroon = end of year AIP/SUP/ENRC/ARC/VNC cycle. Black = AIP AMDT cycle without associated VNC or ENRC/ARC production.
