# 2023 – Gisborne and Hawke's Bay Performance Based Navigation Airspace Changes Public Consultation

# 1. Background

An initial review of Hawkes Bay and Gisborne airspace commenced in 2017 and submissions from users were requested at that time and required before 5 September 2017. Due to circumstances Airways then delayed the implementation of Precision Based Navigation (PBN) procedures for this airspace until November 2018; the '2017 East Coast airspace review – Gisborne and Hawke's Bay was put on hold. A further round of consultation was conducted in 2019. Unfortunately, since that time there has been further delays and PBN procedures, including the proposed airspace changes required for these procedures, are now planned for November 2023.

To inform their current airspace application for these change Airways have also held a further round of stakeholder consultation meetings at Gisborne and Napier airports, on 14 and 15 November 2022 respectively. The purpose of the meetings was to inform local users about the PBN implementation concepts that Airways have developed. The Airways Team also sought feedback on potential issues, hazards and risks, and presented an anticipated Airways PBN implementation timeline; the Airways presentation information covered during these consultation meetings can be viewed on the CAA website airspace review links. Following these consultation meetings Airways have now submitted the airspace change petitions to CAA which include requirements for the proposed PBN route structure, Standard Instrument Departures (SIDs) and Standard Arrival Routes (STARs).

Most of the submissions received during the initial 2017 and 2019 consultation periods included comments on the controlled airspace areas and size. However, without the final proposed controlled airspace changes, it was not possible at that time for CAA to action any of those requests and feedback. Therefore, given the extended implementation delay since the previous consultation periods and acknowledging that stakeholders may have changed in the interim period, CAA is now conducting a further full round of consultation. All stakeholders should resubmit their earlier feedback or submit afresh based on the current application information as now provided by Airways.

A summary of the submissions received will be published in February 2023.

For ease of reference, Airways has submitted two separate petitions requesting controlled airspace changes for the Hawke's Bay and Gisborne areas.

Civil Aviation Rule 71.9 requires the Director to consult with affected persons, organisations and representative groups within the aviation industry before making a designation or classification of airspace.

The Director invites feedback in regard to the proposed controlled airspace changes, as well as any other proposals made by users.

After reviewing all submissions, if it is considered necessary, further CAA consultation meetings at Gisborne and Napier may be held with users in March 2023 to discuss the airspace amendments. Meeting date(s) will be advised in late February 2023 if these are to be held.

Once feedback from users is received, and any further airspace user consultation meetings have taken place, the final airspace changes will be published for users to make any further submissions prior to the visual navigation chart update cut-off date on 11 May 2023.
