### Rule objective

The objective of amendment 6 to Part 115 is to replace the term "automatic ELT" with the term "AELS" in rule 115.603, rule 115.753, and rule 115.803.

#### **Extent of consultation**

A Notice of Proposed Rulemaking, NPRM 18-01, containing the proposed amendment was issued for public consultation under Docket 16/CAR/8 on 4 September 2017.

The NPRM was published on the CAA website on 4 September 2017, notified to the industry by automatic email alerts, and notified in the Gazette on 7 September 2017. A copy of the NPRM was sent to:

- The Ministry of Transport
- Internal CAA stakeholders
- Members of the CAA Aircraft Emergency Location System (AELS) Rules Drafting Group.

A period of 28 days was allowed for comment on the proposed rule.

# Summary of submissions

Nine written submissions and no oral comments were received on the NPRM. A summary of submissions for this NPRM is available on the CAA website. There were no submissions relating to the proposed amendment to this Part.

#### **Examination of submissions**

Submissions may be examined by application to the Docket Clerk at the Civil Aviation Authority between 8:30 am and 4:30 pm on weekdays, except statutory holidays.

#### Insertion of amendments

The amendments to the rules in this Part are reflected by:

- revoking and replacing rule 115.603 to replace the term "automatic ELT" with the term "AELS"; and
- revoking and replacing rule 115.753 to replace the term "automatic ELT" with the term "AELS"; and
- revoking and replacing rule 115.803 to replace the term :automatic ELT" with the term "AELS".

#### Effective date of rule

Amendment 6 to Part 115 comes into force on 18 May 2018.

# Part 115 Adventure Aviation, Initial Issue-Certification and Operations

Rule 115.603 is revoked and replaced with the following rule:

### 115.603 Instruments and equipment – glider

A holder of an adventure aviation operator certificate conducting an adventure aviation operation using a glider must ensure that—

- (1) each glider used for the operation is equipped under the applicable instrument and equipment requirements prescribed in Subpart F of Part 91, Subpart C of Part 104, and this Part; and
- (2) the instruments and equipment required by Part 104 have been installed under the glider manufacturer's instructions or other equivalent instructions acceptable to the Director; and
- (3) despite rule 91.529(e), each glider used for the operation is equipped with an AELS, or the pilot-in-command is equipped with an ELT(S) or PLB that meets the applicable standard in Part 91 Appendix A.

### Rule 115.753 is revoked and replaced with the following rule:

# 115.753 Instruments and equipment

A holder of an adventure aviation operator certificate conducting a special aircraft operation must ensure that each aircraft used for the special aircraft operation is equipped with—

- (1) instruments and equipment that meet the requirements of Part 91 and this Part; and
- (2) an AELS under rule 91.529.

# Rule 115.803 is revoked and replaced with the following rule:

# 115.803 Instruments and equipment – microlight aircraft

A holder of an adventure aviation operator certificate conducting an adventure aviation operation using a microlight aircraft must ensure that each microlight aircraft used for the operation—

- (1) is equipped with the applicable instruments and equipment specified in rules 91.509, 103.221(a), and 103.221(c)(2); and
- (2) despite rule 91.529(e), is equipped with an AELS, or the pilot-in-command is equipped with an ELT(S) or PLB that meets the applicable standard in Part 91 Appendix A and is maintained under rule 91.605(e)(4).
