# Invitation to attend AVSEC Instructors Course 24 – 28 February 2025

The Auckland Aviation Security Training Centre (ASTC) has scheduled the regional ICAO AVSEC Instructors Course to be held over the dates of 24 – 28 February 2025 at the Auckland training centre. The Auckland ICAO ASTC, as one of the ICAO Aviation Security Training Centres within the APAC region, has a fundamental role to play in assisting States within the APAC region in strengthening their capacity building efforts and enhancing their capability to implement International Standards and Recommended Practices and remedying aviation security deficiencies.

This regional Avsec Instructors Course is a five (5) day course and will be conducted in English. All participants should be fluent in English language as there are no translation or interpretation facilities.

#### **Target Audience**

The AVSEC Instructors course is aimed at aviation security personnel who have a role in the practical training of aviation security staff and will enable instructors to present specialized aviation security training courses (in-house) to aviation security personnel.

## **Course Objectives:**

The AVSEC Instructors Course has been designed to enable participants to:

- Conduct AVSEC training applying the general principles of learning and instruction
- Correctly present validated material-dependent training courses
- Identify, select and prepare appropriate teaching aids
- Develop or modify training objectives and tests as appropriate to meet National requirement; and
- Identify and use various instructional methods as appropriate

## **Workshop Fees**

Each participant will be charged an administration fee of **NZ\$835.00** cover the basic administration costs of the course. Please note that airfares, hotel and any other miscellaneous expenses must be met by the participants' organisation.
